### Part I Eligibility Criteria

- (1) Flats under the Flat-for-Sale Scheme Secondary Market Scheme ("SMS") in this application form refer to flats sold under the Flat-for-Sale Scheme ("FFSS") / Subsidised Sale Flats Project ("SSFP") which are assignable subject to the regulations of SMS.
- (2) This application form is applicable for the following FFSS flat owners who join the Flat for Flat Pilot Scheme for Elderly Owners ("FFPS"):
  - (i) All applicant(s) and listed family member(s) must be 60 years of age or above;
  - (ii) Applicant(s) must be the owner and all the joint owner(s) (if any) of a flat in the designated subsidised sale developments of Hong Kong Housing Society ("HS") ("the Flat");
  - (iii) One of the applicants must have owned or co-owned with joint owner(s) the title of the Flat (from the date of signing the Deed of Assignment in respect of the Flat) for 10 years or above on the date of submitting the application form, if the applicant(s) acquired the ownership in the capacity as the beneficiary(ies) of the estate of the deceased owner, the title of the Flat must have reached 10 years or above from the date of the Deed of Assent by virtue of which the beneficiary(ies) of the estate of the deceased owner acquired the Flat;
  - (iv) The Flat is still subject to the restrictions on alienation of the Government Land Grant and the Modification Letter(s) (flat with premium unpaid);
  - (v) Eligible applicant(s) who is/are holding a valid "Certificate of Availability for Sale" ("CAS") under SMS can also apply. The applicant(s) is/are required to provide the Certificate No. of the CAS for HS's reference;
  - (vi) Except for the original Flat, neither the applicant(s) nor any listed family members has, during the period from 24 months prior to the date of submitting the application form and up to the date of signing the Provisional Agreement for Sale and Purchase of the new flat:
    - (a) owned or co-owned any domestic property in Hong Kong or any interest in such kind of property; or
    - (b) entered into any agreements (including Provisional Agreement for Sale and Purchase) to purchase any domestic property in Hong Kong; or
    - (c) owned more than 50% of the shares in a company in Hong Kong which directly or through a subsidiary company owned any domestic property in Hong Kong; or
    - (d) been a beneficiary of any domestic property (including land) in Hong Kong; or

- (e) assigned any domestic property in Hong Kong or any interest in such property in Hong Kong (the date of assignment means the date of execution of the Deed of Assignment), or

Domestic property include any domestic property, uncompleted domestic property, rooftop structures approved by the Buildings Authority, domestic building lots and small house grants approved by the Lands Department in Hong Kong.
