Information for Applicants

1 Purpose and Method of Collecting Personal Data

- 1.1 The personal data contained in the Application Form is used by the Hong Kong Housing Society ("HKHS") for the application for consent to transfer of ownership related purposes.

2 Transfer of Personal Data

The HKHS and its authorized officers, while collecting the personal data required for the verification of such contained in the Application Form, may for the purpose of the said collection or its directly related usages, transfer the personal data on the Application Form to other divisions / offices of HKHS, HKHS's solicitors, other service providers, relevant government departments (including but not limited to the Housing Department, Transport and Housing Bureau, Lands Department and Rating & Valuation Department), public / private organizations and any other third party in possession of the personal data of the owner. The personal data on the Application Form as well as the Consent that may be issued in response to such application may for such reason be disclosed to the said government departments, public / private organizations and any other relevant third party.

3 Access to Personal Particulars

Pursuant to the Personal Data (Privacy) Ordinance, the owner(s) / agent for owner(s) are entitled to request access to and correction of his/her personal particulars contained in the Application Form. A fee may be charged for such requests.
